Net Asset Backing – 31 May 2009

The Directors advise that the consolidated unaudited net asset backing of the company's shares at 31 May 2009 was \$1.17 per share.


The company is a long-term equity investor and does not intend to dispose of its total portfolio. If estimated tax at 30% on unrealised portfolio gains were to be recognised, net asset backing would be \$1.15 per share.

As at 31 May 2009 Brickworks Investment Company Limited's share price (BKI.ASX) was trading at a 10% discount to the Pre Tax NTA and an 8% discount to the Post Tax NTA.
